# FAMILY PLANNING AND UNDERSTANDING FERTILITY BEHAVIOUR AMONG BANJARA TRIBE OF KARNATAKA

#### **Introduction:**

The study on family planning helps us with useful clues for understanding the fertility behaviour of the couples. It will also provide us with some insight into the cost-benefit considerations of parents, both are the conscious and sub-conscious levels for desiring many or few children. This study among Banjaras will help in bridging the gaps in the accumulated knowledge on the subject. However it is surprising that conspicuously less attention has been paid to factors which motivate people for preparing or rejecting different family planning methods. The significance of such information is more important because resistance to family planning in India is due to the unavailability of a method which is acceptable to all. Despite the fear that the Banjaras have about vasectomy and tubectomy operations, a large number of couples among this community get sterilized every year. Similarly the users of oral contraceptives, it would be of interest to find out shy people accept one or the other method. Such investigation may provide some information about different factors associated with the family planning.

Family planning practices are influenced by high fertility. Early age of marriage and low level of family planning is responsible for the fertility. Therefore the study of Family Planning
