Domestic Violence means a broad rang a violent acts which is committed by any one member of a family against another. It includes not only physically but also verbal, sexual abuse and psychologically harassment.

Mostly in Indian Society domestic violence in always believed to be inflected as on female, wife and women. But it was found that during some personal interactions with many males in our societyor in any organization i.e. offices, pubic place and industries etc. male persons are also suffering from such type of crime. Sometimes many courts also commented on false allegations of such type of domestic violence by females. National family Health Survey report 2004 shows that some times violence against man inflicted by wife, female partner and mostly about 3 crore man are tortured mentally and physically by wife's relations in India.

"Save family foundation along with my nation in Delhi conducted a study of violence against men from April 2005 to March, 2006, total sampling methods 1,650 men were observed and interviewed, with them, knowing personal cases view of them and found most of the respondents were suffering with most abusive and dominating behaviour of their wives.

According to the WHO report 2002, in India there is a gender paradox in society about men and women thinking women always dominant committing suicide for false allegation on men but on the other side men die by suicide more frequently then women.

Suggestion

To stop the legal terrorism Section 498A and ant dowry laws, Dowry Prohibition Act 1961 passed by the Supreme Court of India. There is a need to stop the misuse of section 498A. Because there is not any law where a man can larger a lodge a strong complaint against his crucial situation that created by his wife and relatives.

Even after divorce cases of maintenance finance, rape, false allegation children's property right are also increasing. The law related to man should be a spouse crime but it should not be differentiated with gender.

So there is a need for protection to both man & women from the spousal crime in a family.
