The National Agency for Project Management under the President of the Republic of Uzbekistan is the competent authority for licensing activities in the field of crypto-assets turnover. National Agency for Project Management under the President of the Republic of Uzbekistan together with the Ministry of Information Technologies and Communications for the development of digitization activities conditions are created.

Project Management Agency to assist in the quality and timeliness of projects financed by the State Budget of the Republic of Uzbekistan, state trust funds, foreign loans, borrowings, grants attracted by the Republic of Uzbekistan also monitors the introduction of digital technologies in the supply chain.
